New Member Highlight

The FJA Spotlights the Honorable DeAndrea Gist Benjamin



The FJA Celebrates the Appointment of Judge DeAndrea Gist Benjamin to the United States Court of Appeals for the Fourth Circuit. Upon confirmation, Judge Benjamin became the second woman of color, as well as the first person of color from South Carolina, to serve on the Fourth Circuit.

Judge Benjamin has strong ties to South Carolina as she has been a resident of Columbia, South Carolina her entire life. She attended Winthrop University, where she graduated with a Bachelor of Arts degree and received the Order of the Omega. Judge Benjamin then went on to earn her Juris Doctor from the University of South Carolina.

Judge Benjamin started her legal career serving as a law clerk to the Honorable L. Casey Manning of the Fifth Judicial Circuit in South Carolina. After her clerkship she worked as an Assistant Solicitor for the Fifth Judicial Circuit Solicitor's Office's Juvenile and Family Division. Following her time at the Juvenile and Family Court Division, she became an Assistant Attorney General, often prosecuting cases that dealt with crimes against women and children. She then joined Gist Law Firm, where she was a partner and worked on employment, family, and personal injury matters at both the federal and state levels.

In 2004, Judge Benjamin joined the City of Columbia's Municipal Court. There she ruled on misdemeanor cases while also serving on both the Quality of Life Court and the Specialized Criminal Domestic Violence Court. In 2011, the South Carolina General Assembly appointed Judge Benjamin to serve on South Carolina's Fifth Judicial Circuit. While at the Fifth Judicial Circuit, she served as Chief Administrative Judge and Presiding Judge of the State Grand Jury. She would also fill in on the South Carolina Supreme Court.

Upon Judge Benjamin's confirmation to the bench, South Carolina Congressman Jim Clyburn said: "A proud product of South Carolina public schools and universities, Judge Benjamin is an experienced jurist with a wealth of knowledge and varied life experiences necessary to serve with distinction."

Judge Richard Gergel has expressed that "Judge DeAndrea Gist Benjamin came to the federal appellate bench with experience as a former prosecutor, assistant attorney general, attorney in private practice, municipal judge, and state trial judge. She was widely admired while on the state trial bench for her firm but fair management of her courtroom and respectful treatment of counsel and parties. She and her husband, Steve Benjamin, the former mayor of Columbia, have two daughters."

On the occasion of her investiture ceremony, held November 1, 2023, Chief Justice Donald W. Beatty of the South Carolina Supreme Court remarked, "as chief justice, I had the opportunity to see her development as a jurist She displayed exemplary judicial temperament and a strong command of the law. Her work ethic is unassailable."

We welcome Judge Benjamin to the federal judiciary and the FJA.

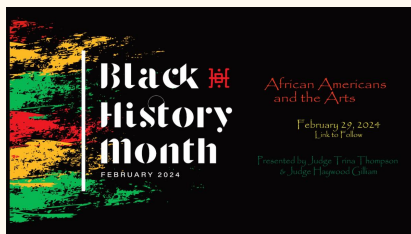
Our Clerkship Chat programs, which are panels on clerking that we hold at law schools that traditionally do not send many students to federal clerkships, held its first program of the new year. On February 29, at the University of Wyoming College of Law, Judge Veronica Rossman, Tenth Circuit, moderated a panel on which Circuit Judge Gregory A. Phillips, Tenth Circuit, District Judge Julie A. Robinson, District of Kansas, and District Judge Margaret Strickland, District of New Mexico, participated. By all accounts, the panel was well-received by the law students. We really appreciate the efforts of all the judges involved in making this panel such a success. This month, we look forward to holding another Clerkship Chat program at Florida International University. We are also considering expanding the program to provide law schools that don't get many visitors who are federal judges, often because of their locations, with panels on federal subjects of interest to law students, such as off-the-beaten-path law schools, that do not get visited often by federal judges. We hope to host panels to discuss such topics as pathways to the bench, what it's like to be a federal judge, and pointers for federal practice. Ethics

It's been a busy month in the federal judiciary on the ethics front, and we are pleased to highlight valuable guidance and tools to ensure we all meet our ethical obligations.

First, please remember that judges are obligated to promptly report attendance at privately funded seminars. The AO recently distributed a memorandum detailing this reporting requirement.



Second, the Committee on Judicial Conduct and Disability recently published a Digest of Authorities on the Judicial Conduct and Disability Act. An informative memorandum from Committee Chair, Judge William Traxler, explains the Digest contents and how to access it. This is a valuable resource for all judges and senior staff in understanding the mechanics of the Act, but it's especially relevant for Chief Circuit Judges, circuit judicial council members, and circuit staff tasked with implementing the Act.

Third, the Committee on Codes of Conduct recently revised Advisory Opinion No. 57, regarding recusal issues arising out of parent-subsidiary relationships between companies. We commend this new and important guidance to you.

Finally, the Committee on Codes of Conduct has published a new conflict checklist designed specifically for law clerks and revised three other conflicts checklists. The checklists along with the Committee's transmittal memorandum explaining how a judge and his staff should utilize them are valuable tools as we uphold the highest values of the Judiciary.

Quadrennial

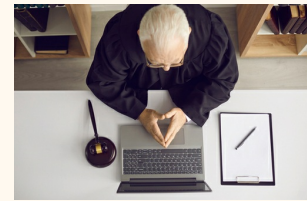
