Dear Federal Judges Association (FJA) Members:

As we enter the heart of October, a month often known for a transition to Fall and unpredictable weather, we find ourselves in the midst of storm season. This month has already brought two significant hurricanes to states in the Southeast coast, leaving behind paths of destruction. On behalf of the FJA executive committee, our hearts go out to those in our judicial family who have been impacted by Hurricane Helene and Hurricane Milton, and we stand in solidarity with you during this challenging time.



At the same time, another type of storm is brewing in the judicial world. As mentioned in our last newsletter, the

JUDGES Act calls for 66 new permanent judgeships in the jurisdictions most burdened by the increase in caseloads. The bill is currently pending before the House and is intended to be brought to the floor in November (after the recess). We urge that all judges in the affected districts reach out to their local representatives and continue the momentum during this recess period. While natural disasters may be beyond our control, we can navigate this "judicial storm" and shape the future of the judiciary for years to come.

Member Spotlight

Second Circuit Judge Sarah A. L. Merriam Being Different and Making a Difference

"Go do good, interesting things. Do them well, and it will work out." Sarah A.L. Merriam often shares this advice with young people, but she has also lived it.

Born of her active-duty navy officer-father and her teacher-mother, Sarah Ann Leilani Merriam, began her life's journey in Honolulu, Hawaii. At six months old, her short stint in paradise ended when her family moved to North Carolina, and then, later, to New Haven, Connecticut, where she was raised.

Her father left active-duty service and attended law school (Sarah, as a grade-schooler, sometimes attended classes with him.) Her mother then left teaching to become a lawyer when Sarah was in high school. Despite having parents who both worked in the law, and while it is probably not too surprising that Sarah, ultimately, followed in their footsteps, Sarah didn't see her life going that way just yet.

Sarah eventually enrolled at Georgetown University where she studied comparative government and where her interest in environmental politics took root. Sarah's interest in state and local politics led her to volunteer for, and then work for, several political campaigns. Sarah loved nothing more than walking precincts and encouraging people to become involved in the political process. At the same time, she worked other jobs – everything from running a fuel dock at a marina to serving fried clams at a counter to being a live-in nanny for three small children.

Her love of grassroots action was motivated by a desire to help others – real people with real

problems. After graduating from college, and putting her skills in politics to work, Judge Merriam worked as the Political Director for a public employees' union. Working closely with the union's attorneys and with political leaders, Judge Merriam decided that becoming a lawyer would better position her to help those who most needed it. Due to her work in labor relations, Judge Merriam was offered a scholarship to University of Connecticut School of Law. She excelled at UConn—she was ranked first in her class—and later transferred to Yale, where she completed her legal education.

After leaving law school, Judge Merriam clerked for District Judge Alvin W. Thompson. While her clerkship was scheduled to last for one year, she stayed for two, not only because she excelled at the job, but because she enjoyed it so much. It was in that role, as a law clerk at the trial court level, that she first sensed that she wanted to work in criminal defense, and, specifically as a federal public defender. She, subsequently, clerked for Judge Thomas J. Meskill in the United States Court of Appeals for the Second Circuit, before going into private practice, where she split her time between civil and criminal cases. Though she loved the work, and especially her criminal defense work, she left the law and returned to politics when she received the call to work on a congressional campaign.

When the campaign trail came to its end, Judge Merriam pondered what to do next. As luck would have it, a position with the Office of the Federal Public Defender for the District of Connecticut opened up. At the time, there were only six attorneys working in that office, and vacancies were rare. Aware of the importance of, and satisfaction that comes with, representing criminal defendants, Judge Merriam applied immediately, gratefully accepted the job, and worked in that position for the next eight years. She describes that opportunity as one of the most challenging but rewarding experiences of her life.

In 2015, Judge Merriam applied to become a Magistrate Judge in the District of Connecticut, though the Court, like many other Districts at that time, had never appointed an Assistant Federal Public Defender to a judicial role. Foreseeing the brilliant jurist she would become, the District of Connecticut Judges appointed Judge Merriam as a Magistrate Judge. Then, in 2021, President Joe Biden appointed Judge Merriam to be a District Judge for the District of Connecticut. Less than one year later, President Biden appointed her to be a Judge for the Second Circuit.

Judge Merriam believes that she is the first former Magistrate Judge to be appointed to the Second Circuit, and she is one of a very few to serve on the Court who have a background in criminal defense. Judge Merriam recognizes the importance of having a diversity of professional experience on the bench, saying: "I knew my professional background was different when I applied for the position, and I hoped that could help me make a difference." Since becoming a Judge, she has appreciated how her great diversity of personal and professional experience, both on and off the bench, brings significant knowledge and insight to bear in each case.

When asked what advice she gives young people, Judge Merriam gave the advice that she has spent her adult life following: "Do things that give you real-life skills and make you interesting. Go do good, interesting things. Do them well, and it will all work out."

Cape Town, South Africa is the site of the International Association of Judges Annual Meeting, which starts October 17th-23. Your FJA Delegation will contribute to all facets of the gathering of 92 member countries' delegates, participating in each of four Study Commissions, a Working Group for the Assistance of Judges, and meetings of the Central Council, also known as as the General Assembly. The following two Reports from the First and Fourth Study Commission have been codified from each member country's Questionnaire Submissions. Prepared and presented by the Presidents of the commissions, Senior District Judge Marilyn Huff (First SC) and Senior Circuit Judge Margaret McKeown (Fourth SC), these Final reports are printed, in full for your information.

Also, the emphasis on AI in the legal world will be discussed by Margaret McKeown who will also present a Power Point at the General Assembly meeting. This will be provided next

month.

On September 20th, Marilyn Huff also contributed to a special Podcast presentation for the International Forum ("High Culture of Jurisdiction" on the impartiality and quality of the judge). Click **HERE** to open the presentation program.

All six FJA Delegates will attend and participate in the ANAO geographic group meetings on Oct. 17. ANAO is led by former FJA President Allyson Duncan who also serves as a vice-president of the IAJ.



Member Judges around the country are actively involved in civics and service to the community. The FJA gives a shout-out to the following members:

2024 Distinguished Federal Judicial Service Award

...and the winners are Judges Beth Bloom and Robin Rosenberg! The Supreme Court of Florida recognized the "outstanding and sustained service to the public" rendered by Judges Bloom and Rosenberg. The award honors each of their individual commitments to the community, but specifically highlights their development and dissemination of the Civil Discourse and Difficult Decisions Program which brings students, volunteer lawyers and federal judges together to discuss critical life skills, civil discourse and adult decisions with permanent legal consequences. The program has reached thousands of students across the country.

Oral History Tells the Story of Judge Cercone

The community came together to celebrate the life and service of Judge David S. Cercone of the Western District of Pennsylvania. The Western District of Pennsylvania's Historical Committee interviewed Judge Cercone, family and friends who reflected on his life, legal career, and judicial service. Among those present for the presentation of the oral history were long-time friends, Chuck Fusina, Gov. John R. Kasich, and Judge Guido A. DeAngelis. After the presentation, Judge Mark R. Hornak, Chief Judge of the Western District of Pennsylvania said, "Judge Cercone's oral history proves that nice guys do finish first."

Miller (Arkansas-Eastern) as chair of the Committee on Judicial Resources. Judge Richard J. Sullivan (Second Circuit) was extended for one year as chair of the Committee on Judicial Security. Judge Nancy E. Brasel (Minnesota) succeeded Judge Marcia Morales Howard (Florida-Middle) as chair of the Committee on the Administration of the Magistrate Judges System. Judge John D. Bates (District of Columbia) was extended for one year as chair of the Committee on Rules of Practice and Procedure. Judge Allison H. Eid (Tenth Circuit) succeeded Judge Jay S. Bybee (Ninth Circuit) as chair of the Advisory Committee on Appellate Rules. Judge Jesse M. Furman (New York-Southern) succeeded Chief Judge Patrick J. Schiltz (Minnesota) as chair of the Advisory Committee on Evidence Rules. We extend our thanks to each of the new and departing Chairs for their service to the Judiciary.

Chief Justice Roberts has also appointed FJA President, **Judge J. Michelle Childs** to the Supreme Court Fellows Commission.
