Member Spotlight



"Shoebomber prosecutor comes to the trade court" is not the typical headline reporting on the arrival of a new member of the United States Court of International Trade. But then, Judge Gary S. Katzmann has not had a very "typical" life or career in any sense. "Exceptional" is more appropriate.

Justice Stephen Breyer said of Judge Katzmann, before swearing him into the Court: "Gary was my first law clerk [on the First Circuit] ...and he helped me right along."

"My new colleagues told me that if I had a really difficult legal or ethical question, I had to see Chief Appellate Attorney Katzmann," said former federal prosecutor and now Massachusetts Superior Court Judge Robert Ullmann.

Alluding to Judge Katzmann's service as an Assistant U.S. Attorney in Boston, he added: "I soon learned that Gary was not only smarter than the rest of us, but also generous with his time, and unlike some super smart people, he was grounded in the real world.... I quickly became a member of the Gary Katzmann fan club." Author of books on criminal process and juvenile justice, his impact nationally was shown in the pension fraud initiative he designed for the Attorney General, in the health care fraud statute he drafted, and in sentencing reform.

Former fellow Associate Justice of the Massachusetts Appeals Court, Cynthia Cohen, described Judge Katzmann's work as "extraordinary" and stated that his many civil and criminal opinions on that court showed that "legal scholarship and intellectual integrity ... go hand in hand with empathy and respect for the people whose cases come to the court." On Judge Katzmann's departure in 2016 from the Appeals Court after twelve years of service, Chief Justice Scott Kafker stated succinctly: "The Federal Judiciary is most fortunate. Our great loss is their great gain."

And, speaking of family, Judge Katzmann's family of origin and his own family remain anchors. Judge Katzmann says that he was so deeply fortunate to have a father who escaped Nazi Germany at age 14, served in World War II, and became an engineer. His mother grew up in Brooklyn during the Great Depression, the daughter of two hard-working immigrant parents from Russia and Belarus. Judge Katzmann carries forward his quintessentially American-immigrant heritage into his own family. From his mother and father, he and his three siblings drew deep values of gratitude to the country that gave their family a new home, education, and above all, service. Judge Katzmann and his identical twin brother, Robert, became distinguished jurists, with Judge Robert Katzmann serving as Chief Judge of the Second Circuit Court of Appeals before his passing far too young. Public school graduates, both studied at Columbia University and Yale Law. Judge Katzmann also received master's degrees from Oxford and Yale Universities.

Judge Katzmann's dedication to service is not limited to his time on the bench; it goes far beyond it. One example is his dedication to Discovering Justice, a nonprofit organization designed to teach elementary and middle school students in the Boston area and beyond about the justice system and the central role of the judiciary in the U.S. constitutional system. Judge Katzmann has served Discovering Justice since its inception 25 years ago.

Ann Gogol, longtime Chief Operating Officer of the program, noted Judge Katzmann's role on its various committees. She emphasized his tireless mentoring of students, week after week, year after year, for more than a quarter of a century. Ms. Gogol further acknowledged his willingness to share his life experiences as an attorney, enabling the students to envision

themselves becoming attorneys or judges.

Ms. Gogol spoke of Judge Katzmann's work as a mock trial judge: "He makes time at the end of each mock trial to address each student individually, and always finds positive things to say about their performance. Gary has a really special way of working with young people, pointing out small positive things about their performance that others may not have noticed or appreciated, and offering constructive suggestions about others."

Judge Katzmann's eagerness to participate in Discovering Justice's mock trial and appeals program was as palpable as his tireless dedication. Ms. Gogol commented, "Some years, Gary would volunteer before the invitation even issued!" Even after he was confirmed to the U.S. Court of International Trade, whose courthouse is in Manhattan, he has continued to maintain his deep commitment notwithstanding the vicissitudes of weather, Amtrak, and other vagaries. "Some nights since he began on the CIT, the event was starting and Gary would come flying in the doors, sprinting or cabbing from South Station-Boston after the train got stuck. No one had a doubt he would make it." "He leads by example. At times, a student will ask a question and Judge Katzmann will say that he does not know the answer. So, the student says: 'you really don't know the answer to the question?' And, he says 'yes, and it is ok to say that.' He puts them at ease."

Ms. Gogol concluded: "[H]e is an incredibly humble, kind, caring person: a special, wonderful human being."

Senior and Retired Judges

Co-Chairs: Larry Piersol and James G. Carr



The Judicial Resources Subcommittee tasked with considering senior judge staffing met on August 22, 2024, via Zoom. After much discussion, it was determined that a proposed position would be sent to the subcommittee members for comment. The proposed position might be altered somewhat by the subcommittee chair, but from the discussion it appears that the proposed position to be sent to the subcommittee members for comment would be along the following lines:

- 1. A senior status judge would have to perform some level of work beyond *de minimus* to be entitled to maintain a staff, with that level of work to be set by each circuit. (It is reported that at this time only two circuits have a stated requirement for 1 staff person.)
- 2. Staffing levels in the circuits have to be based on objective standards.
- 3. Nothing is to be based on non-case-related work. (There was discussion on this topic with some favoring some case credit for service on at least some of the Judicial Conference Committees that require a good deal of time.)
- 4. Deviation from a circuit's own standards is to be reported by the circuit to the Judicial Resources Committee, possibly on an annual basis.
- 5. Whatever circuit requirements result from this change should be clearly communicated to all interested parties, including judges who are considering taking senior status.

It is anticipated that a recommendation from the subcommittee would be submitted as a final recommendation to the full Judicial Resources Committee for its recommendation to the Budget Committee.

As always, the Senior and Retired Judges Committee and President Childs will follow this process carefully and will keep FJA members advised as it progresses.

FJA Pursues Immediate Passage of the Bipartisan JUDGES Act of 2024

In keeping with its purpose to sustain our system of justice, the FJA is urging Congress to pass The JUDGES (Judicial Understaffing Delays Getting Emergencies Solved) Act of 2024. As reported in the Bench Press last month, the companion bill in the Senate passed UNANIMOUSLY on August 1, 2024. This bipartisan bill would implement the 2023 Article III Judgeship Recommendation of the Judicial Conference of the United States, which called for 66 new permanent judgeships in the jurisdictions most burdened by the crushing increase in caseloads. The judgeships would be filled over a period of ten years. It has been two decades since Congress last authorized new district judgeships. This represents the longest period since district courts of the United States were established in 1789 that Congress has not authorized any new permanent district court judgeships. Judge Timothy J. Corrigan, Chief Judge of the Middle District of Florida, shared his perspective with Congressman Aaron Bean in his letter linked below.

As reflected in a recent CNN piece, many of our FJA members are standing in active support of this effort. Our President, with the approval of the executive committee, has sent a letter to Congress, where a substantial number of members of the House are working in a bipartisan effort to move this bill forward before the end of session. Just yesterday, Congressman Darrell Issa (CA-48), Chairman of the House Judiciary Subcommittee on Courts, Intellectual Property, and the Internet, introduced, with significant bipartisan support, a companion House Bill, the Judicial Understaffing Delays Getting Emergencies Solved Act of 2024 ("JUDGES Act"). Representative Issa stated eloquently: "A severe shortage of judges eventually delivers an array of complications to our courts – and over time, the problem only grows worse until justice is routinely delayed and therefore denied."

The FJA is working in concert with and support of the Chief Judges of the affected districts. We remain hopeful that this bill will be passed and the work of the Courts can be maintained at the high levels our citizens expect. Thanks to all who are working to achieve this goal.

Advisory Opinions Issued This Week Urge Judges to Prohibit Clerks from Seeking Employment With Political Organizations During the Clerkship Term

This week, the Committee on Codes of Conduct within the Federal Conference of the United States published two new important Advisory Opinions. The Opinions advise Federal judges to prohibit their law clerks from applying during the pendency of their clerkships for post-clerkship jobs with political organizations. Specifically, the Committee advises: "a judge should restrict his or her law clerks from seeking or pursuing post-clerkship employment with a political organization while the law clerk is employed by the court." The Committee advises that such applications and interest by the law clerk may connect the judge's chambers to political activity, which the committee concludes "could compromise the independence of the judiciary." Instead, the Committee advises that clerks may tell political organizations to contact them after their clerkships end.

The Committee acknowledged that siloing a clerk from work is sufficient to guard against conflicts from pending offers from law firms, DOJ, and federal defender positions. But the Committee concluded that this safeguard was insufficient as applied to political association employment.



Judge Breen Receives 2024 Tennessee Professionalism Award



Judge J. Daniel Breen, a senior judge on the U.S. District Court for the Western District of Tennessee and a longstanding member of the FJA, was recently honored with the Judge Pamela L. Reeves Tennessee Professionalism Award. The Tennessee Professionalism Award is named in honor of the late Judge Pamela L. Reeves, former chief judge of the U.S. District Court for the Eastern District of Tennessee and the first recipient of the award. She was an active leader in both the American Inns of Court and the Tennessee Bar Association, where she was elected the first female president in 1988. The award is given jointly by the Tennessee Bar Association (TBA) and the Tennessee American Inns of Court.

In a letter nominating Judge Breen for this award, Jackson lawyer Sarah Barnett, Vice

President of the Jackson chapter of the American Inns of Court, wrote: "Judge Breen is the embodiment of legal professionalism and outstanding character, as evidenced by his dedication and service to the federal judiciary, the Tennessee Bar, and his community of Jackson, Tennessee." Other letters submitted in support of the nomination praised Judge Breen for his mentorship of younger lawyers and new judges and his support for colleagues rising to leadership roles. TBA President Jim Barry praised Judge Breen's selection as this year's award recipient. "Judge Breen exemplifies the ideals of the Tennessee Professionalism Award. His service to the judiciary and the legal profession reflects the highest standards of the rule of law and the legal profession in Tennessee."

Judge Breen earned his law degree from the University of Tennessee College of Law in 1975 and joined the law firm of Waldrop and Hall in Jackson, Tennessee. He served there for more than 16 years before being appointed a magistrate judge on the U.S. District Court for the Western District of Tennessee in 1991. Judge Breen was appointed as a United States district judge in 2003. He served as chief judge from 2013 until taking senior status in 2017.




