# Member Spotlight

# For a change of pace, this month the FJA spotlights retired judge, Hon. John Gleeson

After a young John Gleeson had wrapped up a clerkship with Judge Boyce Martin on the United States Courts of Appeals for the Sixth Circuit, worked at Cravath, Swain & Moore for four years, and ultimately landed at the U.S. Attorney's office in the Eastern District of New York, he thought he had the perfect job. Arriving on the federal bench in the same courthouse in 1994, Judge Gleeson did not think there was a professional life worth living off the bench. Now, eight years since leaving the bench in 2016, private attorney John Gleeson is again convinced that he



has the best job in the profession.

Almost every federal judge has heard of John Gleeson. As an Assistant U.S. Attorney, Judge Gleeson served as Chief of the Criminal Division, Chief of Special Prosecutions, Chief of Appeals, and Chief of Organized Crime. He took down John Gotti, head of the Gambino family, and Victor Orena, head of the Colombo Families of La Cosa Nostra. The Attorney General recognized Judge Gleeson's work with the Distinguished Service Award.

In 1994, Judge Gleeson was nominated to the federal district court, serving in Brooklyn. He took the bench at the young age of forty-one to the seat vacated by the highly esteemed Judge Jack Weinstein. As a federal judge, Judge Gleeson presided over several MDLs, including antitrust class actions against Mastercard and Visa. His trial judge experience also included overseeing the prosecution of the "Wolf of Wall Street" and actively monitoring a deferred prosecution agreement with HSBC Bank. He was also an outspoken critic of mandatory sentences and the sentencing guidelines.

Judge Gleeson fully expected to follow his mentor Judge Weinstein's lead of spending fifty years on the federal bench. He loved every day as a judge, but twenty-two years on the bench is a long time. And he looked forward to making a change. He initially felt apprehension about the transition from the bench to private practice. Judge Gleeson felt, as he put it, "as nervous as a new trial lawyer." While he had presided over hundreds of trials during his time on the bench, that role is very different from standing in the well of the courtroom. Once Judge Gleeson made the switch to private practice, he landed at Debevoise & Plimpton, working in the Commercial Litigation and White Collar groups. Judge Gleeson maintains an active trial practice and commented that one of the most rewarding aspects was getting to try a case with a former law clerk who is now a law partner. He said of that experience that there are "few things that replicate the judge/law clerk relationship, but trying a case comes close!"

In addition to billing hours, Judge Gleeson is the proud founder of The Holloway Project, a pro bono project involving sentencing reductions. Starting in 2020 with its first win, The Holloway Project has obtained over sixty reductions (more than one per month) under the compassionate release statute with the average reduction between thirty-nine and forty years. Over one hundred present and former Debevoise lawyers have worked on the cases, most of which involved stacked 18 U.S.C. § 924(c) sentences. Judge Gleeson has said that "thanks to the First Step Act, we now have a meaningful 'second look' in the federal system."

Judge Gleeson expanded on this important advocacy when, in 2022, he was confirmed as a commissioner on the United States Sentencing Commission. In that role, he enjoys the intellectual work that goes into sentencing reform at the wholesale level, providing guidance for over 60,000 sentencing hearings each year. Judge Gleeson has said, "The work is rewarding, and I love my colleagues." Judge Carlton Reeves, chair of the United States Sentencing Commission, says, "like so many federal judges, I have long looked up to John Gleeson for his leadership from the bench on criminal justice reform. It is an honor to work alongside him at the Commission, where his deep compassion, vast wisdom, and unmatched courage are doing wonders to make federal sentencing fairer."

Judge Gleeson says he appreciates private practice and acknowledges that it took a little courage to make the jump. "Everyone treats you nice as a judge, but going back into private practice takes a little bit of a runway. There are lots of talented lawyers competing for the business." Judge Gleeson thinks it took him about five years to become fully engaged in the

practice. However, eight years in, John Gleeson feels just like he did as a new U.S. Attorney or a new district judge, and he cannot imagine doing anything different.

# Committee Updates

## Civics and Service

The Civics & Service Committee continues its three major projects: the Naturalization Civics Challenge, the Clerkship Chats, and the Speech Bank. In this edition of *The Bench Press*, we focus on the Naturalization Civics Challenge.

As a reminder, in the Naturalization Civics Challenge, high-school students take the naturalization civics test. If they score at least 90%, we award them an "Excellent Citizen" certificate and invite them to attend a federal-court naturalization ceremony in their home judicial district before a federal judge.

We've now completed the first year of the Naturalization Civics Challenge and have embarked on the second. We think it's been a great success!

Here's what one teacher whose class participated in the Challenge and attended a naturalization ceremony in the Middle District of Georgia had to say:

I took 17 of our students to a Naturalization Ceremony in Columbus, Ga, on September 5, 2024. We got to tour the judge's chambers prior to the ceremony and Judge Clay Land honored our students and included them in the ceremony introduction. It was a wonderful experience overall! My students were very appreciative of the opportunity and had several really great conversations about the process.

This is something I am so happy to have accessible to my school! I hope to continue to participate in the program with more students as the school year continues.



Hon. M. Margaret McKeown, Life Fellow, was announced as the 2024 American Inns of Court Lewis F. Powell Jr. Award recipient. Judge McKeown was presented with the award at the 2024 American Inns of Court Celebration of Excellence at the U.S. Supreme Court on October 26th.

The award is named for Justice Lewis F. Powell Jr., who served as an Associate Justice of the Supreme Court of the United States. The award recognizes attorneys, judges, government officials, journalists, or others who have rendered exemplary service in the areas of professionalism, ethics, civility, and excellence.

Judge McKeown is a senior U.S. Circuit Judge of the U.S. Court of Appeals for the Ninth Circuit, which is based in San Diego. She helped launch the San Diego Appellate American Inn of Court, served as the president of the Federal Judges Association, and is a U.S. delegate to the International Association of Judges.
